Introduction

The last decade much progress has been made in understanding our biodiversity and climate planetary boundaries and the footprint of our consumption and import activities (for <u>Belgium</u>). Our commodity imports have to become sustainable, involving no deforestation and with respect for Indigenous Peoples and human rights in general. The European Regulation on deforestation (EUDR) and the Directive on corporate sustainability due diligence (CSDDD) are corporate supply chain and emerging market requirements towards sustainability of commodity production and consumption that will assist in shaping this agenda. There is also a wider challenge to address the challenges of rural poverty, biodiversity and climate change.

The event aims to enhance awareness amongst stakeholders along the Belgian commodity supply chains from production to import, and facilitate a discussion on how to implement international ambitions on biodiversity, climate change and human rights linked to supply chains and trade. The meeting will present and discuss the role of government and private sector in living up to commitments and meeting market requirements by smallholder farmers to attain a living income and reward sustainability.
